1. Call Court to Order. (BM)
2. Consider approval of Minutes of Commissioners Court Meeting of May 28, 2013.
3. Discuss and consider approval of cooperative agreements by and between Wise County Sheriff's Office/Wise County and each of the Independent School Districts (I.S.D.'s) of Alvord, Chico, Paradise and Slidell, all being for the purpose of providing "school resource officers" (SRO's) for each named School District's designated campuses/facilities. School Superintendents will be present to provide detail information and question & answer session in regards to the agreement requests and plan objectives/priorities. Take appropriate action. 4. Discuss and consider construction, initiation and/or approval of: (i) specifications pursuant to advertising for bids on one or several different items and/or services for purchase (or sale of items); (ii) purchase of specific items; (iii) consider awarding of bids; and (iv) consider giving of notice of cancellation(s) as/if necessary. Take necessary action.
5. Consider accepting donations of personal property and/or various revenues to County (if any). Take necessary action.
6. Discuss and consider approval of Final Plat, The Back Ten, Block 1, in Precinct No. 3. Take appropriate action. (HL)
7. Discuss and consider approval of Replat, Hawk Ridge Addition, Lots 1 R-1 and 1R-2 Block G, in Precinct No. 1. Take appropriate action. (D. White)
8. Discuss and consider the approval of a Resolution FY13-03 for nomination of a candidate to the Wise County Appraisal District (WCAD) to fill a present vacancy on the WCAD's Board of Directors as provided and outlined in Texas Property Tax Code, Section 6.03 (l). (Vacated seat was previously held by Director Member, Joey Luttrull, who has moved from Wise County.) Note: Deadline for nominations to be received by WCAD is June 25, 2013. Reference that certain letter dated May 9, 2013 from WCAD Chief Appraiser, Mr. Mickey Hand to Wise County Judge. Take necessary and/or appropriate action. (BM)
9. Hear recommendation and nomination report from Wise County Commissioners Court's Water Committee (Commissioner K. Burns, P.W. Director Tom Goode and Commissioner D. White) being for discussion and approval consideration of a Board of Director appointment for the Upper Trinity Groundwater Conservation District (UTGCD); said appointment being for a four (4) year term, effective June 1, 2013. Take necessary and appropriate action. (KB) (D.White) (TG) (BM)
10. Discuss and consider approval of a septic repair variance in Precinct 4 at 301 CR 3480. Take appropriate action. (GH)
11. Discuss and consider approval of a Permit and Right-of-Way to FIBERLIGHT to lay, construct, maintain and operate a Fiber Optic Cable under a certain area of County Road 4791 and County Road 4790, being located within Precinct No. 3 . **NOTE:** Reference the design and location platting packet as received from FIBERLIGHT and the requested location and design standards and notes as provided by County Engineer Mr. Chad Davis. Consider approval of Commissioners' requests (if any) for necessary access to enter onto private property so as to clean/clear certain named County road right-of-way areas for improved public safety and/or public transportation safety purposes; such requests as provided for under Transportation Code Chapter 251 (all being in compliance with Texas Constitution Article III – Section 52).
