8. Discuss County appointments to Bridgeport Tax Increment Financing Reinvestment Zone No. 2 Board. Take necessary action. (JDC)
9. Re-Plat Indian Springs Ranch, Phase II, Lots 9R and 10R. Precinct 4. Take necessary action. (JDC) (GK)
10. Consider Final Plat Nicholson Addition, Lot 1. Precinct 1. Take necessary action. (JDC) (DW)
