Community Forum (*The Commissioners Court invites persons with comments or observations related to County issues, projects, and policies to briefly address the Court for the limited purpose of determining whether the matter should be referred to staff for study and response and/or be placed on a future meeting. Anyone speaking during the Community Forum should first identify themselves by their first and last names for the public record. There is a 3-minute time limit, and large groups interested in the same topic should select a spokesperson. State law prohibits the Court from deliberating on any item not listed on the posted agenda.*) (JDC)
5. Hear County Correspondence. (JDC)
6. Consider approval of Minutes of Commissioners Court Meeting of June 23, 2015 and June 29, 2015, and July 13, 2015. Take necessary action. (JDC) (SL)
7. Consider acceptance of Western Surety Bond No. 716079020 for Assistant Fire Marshall Joe Washburn. Take Necessary Action.(JDC) (SL)
8. Review a signed copy of Application to Purchase an Interest in the Surface if Mineral Estate and supporting documents. No action necessary. (JDC) (TA)
9. Discuss renewal of County Health Insurance. Take necessary action. (JDC) (KH)
10. Discuss and consider a possible change order of the jail roof project. Take necessary action. (JDC) (GH) (TA)
11. Consider accepting donations of personal property and/or various revenues to County (if any). Take necessary action.
12. 16. Discuss and consider current status of Weather/Ground/Vegetation conditions for Burn Ban update purposes and for Burn Ban renewal, amendment, revisions, or rescind considerations. Hear reports from Fire Marshal/EMC in regards to recent County fires, State of Texas Reports and neighboring counties' conditions. Hear Burn Ban recommendations and/or Red Flag Day Reports. Take appropriate action. (CB)

17. Accept County Committee Reports and discuss and consider forming and appointment of any new committees needed for any various study areas and/or projects not presently covered. Take necessary and/or appropriate action.
