There is a 3-minute time limit, and large groups interested in the same topic should select a spokesperson. State law prohibits the Court from deliberating on any item not listed on the posted agenda.*) (JDC)

6. Discussion for the purpose of coordination and cooperation for efficiency between precincts. No action will be taken.
7. Re-Plat LP Subdivision, Lots 12R1, 12R2, and 12R3. Precinct 4. Take necessary action. (GK)
8. Re-Plat Review of Platinum One Addition, Lots 1R, 2R1R, and 2R2R. Precinct 3. Take necessary action. (HL)
9. Discuss and consider amended prioritized list of CETRZ projects. Take necessary action. (JDC) (CD)
10. Discuss and consider an order clarifying which County offices and facilities are essential to the functioning of the courts. Take necessary action. (JDC) (TA)
11. Receive update on TAPS organization and operations. (JDC)
