There is a 3-minute time limit, and large groups interested in the same topic should select a spokesperson. 6. Discussion for the purpose of coordination and cooperation for efficiency between precincts. No action will be taken.
7. Consider approval of Minutes of Commissioners Court Meetings of February 09, 2016 and February 10, 2016. Take necessary action. (JDC) (SL)
8. Discuss proposed appointments from Wise County ESD #1 Board of Directors. Take necessary action. (JDC)
9. Consider and act on awarding bid tax sale on Lot 47, Block 1, Runaway Bay Subdivision, Second Installment of Unit 6, an addition to the City of Runaway Bay, Wise County, Texas. Take necessary action. (JDC)
10. Consider accepting donations of personal property and/or various revenues to County (if any). Take necessary action. (KH)
