6. Discussion for the purpose of coordination and cooperation for efficiency between precincts. No action will be taken.
7. Receive FY15 annual audit. Take any necessary action. (JDC) (AM)
8. Consider approval of Minutes of Commissioners Court Meetings of March 14, 2016. Take necessary action. (JDC) (SL)
9. Consider and discuss a variance for acreage/sewer system permit for an address located on N. Hwy 101, Chico, Texas. Take any necessary action. (KB)
10. Discuss and consider changes to the Wise County Employee Handbook & Policy Manual. Take any necessary action. (JDC) (KH) (TA) (JS)
11. Discuss and consider application for state land use lease on vacant land tracts SF/16608, 16609, 16610. Take any necessary action. (JDC) (TA)
12. Consider accepting donations of personal property and/or various revenues to County (if any). Take necessary action. (KH)
