6. Discussion for the purpose of coordination and cooperation for efficiency between precincts. No action will be taken.
7. Consider approval of Minutes of Commissioners Court Meetings of May 16, 2016. Take necessary action. (JDC) (SL)
8. Consider and discuss Medicaid renewal agreement. Take necessary action. (CD)
9. Consider acceptance of Western Surety Continuation Certificate No. 716079020 for Assistant Fire Marshall Joe Washburn. Take Necessary Action. (JDC) (SL)
10. Receive presentation from NCTCOG staff on possible formation of a 9-1-1 district. Take any necessary action. (JDC)
