Such matters must be addressed in writing to the Court in which your case is pending. You are also entitled to consult an attorney of your choice to ascertain your rights and options.

The Board only has jurisdiction to investigate complaints that allege a violation of the Bail Bond Act, the Board may conduct a hearing. Both you and the Bondsman are entitled to be represented by counsel, and conclusion of the hearing, the Board may dismiss the complaint or suspend or revoke the Bondsman's license. Please check below, the violations contained in the act that you allege were committed by a Bondsman:

- Violation of a Bail Bond Act provision or a Rule of The Board.
- Fraudulently obtaining a license or making a false statement or misrepresentation in an application.
- Being finally convicted of a felony or misdemeanor involving moral turpitude.
- Being adjudged bankrupt or becoming insolvent.
- Being adjudged mentally incompetent.
- Failing to pay a final judgment in 30 days.
- Paying or offering to pay commissions or fees to anyone not holding a license.
- Soliciting bail bond business in a building where prisoners are processed or housed.
- Recommending to any client, the employment of any particular attorney or law firm.

- () Falsifying any record or failing to allow inspection of records by the Board or its representative.
- () Operating as a Bondsman while the license is suspended, revoked or expired.
- () On more than one occasion, failing to maintain the minimum amount of security on deposit.
