Since the original watershed agreement became effective on October 18, 1956, it has become necessary to modify that agreement.

The Denton Creek Watershed will benefit from Wise County Water Control and Improvement District No. 1 assisting Wise Soil and Water Conservation District and Wise County with operation and maintenance activities on all works of improvement and any land rights issues affecting the Denton Creek Watershed project, in Wise County. The Wise County WCID No.1 agrees to become a sponsor of the watershed project. The following are current sponsoring local organizations (SLO):

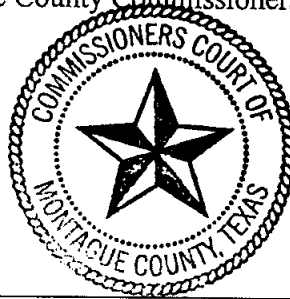
