Re: Legislative Services

Thank you for our recent visit and the opportunity to provide support to you and your colleagues on the Wise County Commissioners Court for ongoing strategy efforts related to your county's participation in the Weatherford College System. I am confident I can contribute significantly to your ongoing efforts and work to ensure the taxpayers of Wise County are well represented. The issues discussed are significant and quite concerning. I have alerted the Wise County delegation and Legislative Leadership. We will want to follow up.

As we have discussed, there is need for immediate planning for the upcoming legislative session, which begins January 10, 2017. Additionally, early filing for legislation begins on November 14, 2016. Given the concerns discussed, I would suggest we act quickly.

I propose to provide the following services to Wise County:

- Meetings and Contacts with local, regulatory and state elected officials, with a strong emphasis on the Wise County Legislative delegation as well as the appropriate contacts at the legislative council and the Texas Higher Education Coordinating Board.
- Draft legislation, secure legislative authors and sponsors and regularly update Wise County delegation.
- Continuous monitoring drafted legislation, as well as other pertinent legislation with exact or similar statute citation code.
- Material Preparation for Advocacy and Outreach Activities (including editing and proofing of documents, testimony, etc.)

Terms

The terms below are proposed on the basis of providing ongoing services until otherwise notified:

- Begin Service - November 1, 2016
- End Service - June 30, 2017
- Fee - \$ 4000 per month

The first month's payment will be required for work to begin. Any expenses will be added to the second month's invoice in consultation with you. All invoices will be sent to your attention, payable in 30 days and addressed to Jerry Valdez Governmental Affairs, LLC, P O Box 12031, Austin, Tx 78711. For Federal Tax purposes, my IRS Tax ID number is 84-1684926. Lastly, each party reserves the right to terminate this agreement with a written 30 day notice.

If this arrangement is satisfactory, I am comfortable with this letter serving as our agreement. However, should you require other documentation I am ready to meet your needs.


