

INTERLOCAL AGREEMENT

THIS INTERLOCAL AGREEMENT ("Agreement") is entered into and in accordance with the provisions of the Interlocal Cooperation Act, Chapter 791, Texas Government Code by and between WISE COUNTY ("COUNTY"), a political subdivision of the State of Texas, and the WISE COUNTY APPRAISAL DISTRICT ("DISTRICT"), also a political subdivision of the State of Texas.

WHEREAS, the Interlocal Cooperation Act allows local governments to contract with one another to perform governmental functions; and

WHEREAS, COUNTY and DISTRICT mutually desire to be subject to the provisions of the Texas Government Code, Chapter 791, the Interlocal Cooperation Act, specifically §791.011 regarding contracts to perform governmental functions and services; and

NOW, THEREFORE, COUNTY and DISTRICT, for the mutual consideration stated herein, agree and understand as follows:

- (1) DISTRICT shall regularly scan all plats filed with the Wise County Clerk's Office for the purpose of creating a digital version of these documents for use by COUNTY. DISTRICT shall not charge COUNTY any fees or expenses for this service, in exchange for COUNTY allowing DISTRICT to have limited access to the digital version of the plats as set forth below.
- (2) DISTRICT shall scan a plat within a reasonable time of being notified by COUNTY of the filing of a new plat. At an agreed upon date and time, a Wise County Clerk's Office employee will bring the mylar of the plat to DISTRICT at DISTRICT's office upon which scan services will be performed. After the plat has been scanned, the Wise County Clerk's Office employee will immediately return the mylar to the Clerk's offices. All such services will be performed at the offices of the DISTRICT, with a Wise County Clerk's Office employee present at all times during the scanning process. A digital image of the plat will be provided to COUNTY after the completion of the scanning in a computer format acceptable to COUNTY stored on a CD-ROM or other storage medium acceptable to COUNTY.
- (3) DISTRICT shall retain an electronic copy of all documents scanned pursuant to this agreement solely for its use in daily operations. In such use, any reproduction of any portion of this information will be allowed by DISTRICT, but only for internal use by DISTRICT during the term of this agreement. Except as provided above, DISTRICT shall not copy, duplicate or distribute (electronically or otherwise) any such documents or information. This prohibition shall survive the termination of this agreement.
- (4) DISTRICT shall neither directly or indirectly make this information available to the public for viewing, reproduction or any other use. Any party requesting copies of this information or requesting to view the information shall be instructed to contact the Wise County Clerk's Office in order to honor terms of this agreement for purpose of not distributing information available to the public via the Wise County Clerk's Office. This prohibition shall survive the termination of this agreement.

- (5) Upon written request by COUNTY, DISTRICT agrees to replace any mylar that is damaged as a result of being scanned at the sole expense of the DISTRICT.
- (6) Either party may terminate this agreement with written notice to the remaining party no less than 30 days prior to the date of termination of said agreement. Upon termination, all copies of the information covered by this agreement shall be returned to COUNTY. All electronic copies of the documents scanned shall be deleted from DISTRICT's computers and backup storage media.
- (7) Neither party to this agreement shall assign its rights or obligations under this agreement, in whole or in part, without the prior written consent of the other party hereto.
- (8) This Agreement shall be effective as of _____, 2005.


