REPORT OF

INDUSTRIAL AND ECONOMIC DEVELOPMENT SUBCOMMITTEE Wise County Long Range Planning Committee

In its current and future industrial and economic development efforts, County government should strive to create the highest quality of life in Wise County, taking into account the following five recommended factors:

1. ENCOURAGE INDUSTRY GROWTH/RETENTION

- County should work with city EDCs and other cities without EDC to attract new industry and should make every effort to retain existing industries.
- County should encourage industry relocation by considering County participation in the construction of roads, utilities, and other infrastructure.

3. EDUCATIONAL SUPPORT AND PARTNERSHIPS

- County should work toward the establishment of an improved county college system.
- County should encourage vocational training/education opportunities.
- County should support business/industry/education partnerships and workforce development.



4. RESPONSIBLE ECONOMIC ENTICEMENTS

- County should not grant tax abatements without an established county policy, which takes into account the capital investment and the economic benefit to the county.
- County should not make grants to industry from general funds.

5. FUTURE TRANSPORTATION PLANNING

- County should work closely with NCTCOG and investigate the feasibility of participating in the Regional Transportation Authority through NCTCOG.
- County should work with TxDOT in the development and planning of roads and highway safety, construction, and expansion.


