First, this was approved by both the District and County Court at Law Judges. It was approved not by one but both department heads. Their intention was to purchase a vehicle closely identical to the vehicle purchased for the District court bailiff.

Second, the bailiffs use the vehicles to transport multiple passengers. These transports are sometimes prisoners and sometimes other county employees.

It is not the bailiff's primary purpose to transport prisoners but it is ultimately their responsibility to make it happen. If transport and courthouse security are unavailable for transport, it is the bailiff's responsibility to transport to and from the county jail as well as make warrant arrests in the courthouse.

The larger vehicle is more efficient for the work required for these tasks. It is also safer to transport prisoners in a larger vehicle. The Fords are not just small, they are too small for the need.
