Hughes called for comments/questions at 8:35 AM. No comments were made.


Hughes called for comments/questions at 8:38 AM. No comments were made.




Hughes adjourned the public hearing at 8:40 AM. There being no further discussion.


Hughes stated the tax rate will be set on September 8, 2014 at the 9:00 AM Commissioners Court meeting.
