Opinion JM-1046 (1989), the expenses for providing the services incident to unsuccessful service of process are equal to or exceed the expenses of actual service and the fee is thus set at the same cost charged for actual service.

Pursuant to Rule 126 of the Texas Rules of Court, all fees, for any/all civil cases originating outside the County of Wise and/or the State of Texas must be collected in advance except when Paupers Oath is filed. The sheriff or constable will not execute any process until fees are received.

**Cancellation fee, Order of Sale or Writ of Execution
(Except Tax Warrant Order of Sale)**

With Plaintiff's direction to withhold, release levy, withhold collection, cancel or recall writ without collection of judgment and cost, shall include all cost incurred and cancellation fee.

Sheriff's and Constable's Commission on Recovery of Execution:

If property goes to auction: 10 percent of first \$5,000.00 or 5 percent of all money over \$5,000.00.

Fee for Subsequent re-issue of papers (The fee for each citation, notice or other paper covered under this fee schedule shall be assessed any time the citation, notice or other paper is re-issued.)
