**2015 Sheriffs' and Constables' Fees Presentation
September 15, 2014**

The 2015 Sheriffs' and Constables Fees are effective January 1, 2015.

Per GC 118.131(d) the Commissioners Court must adopted Sheriffs' and Constables' Fees on or before October 1, 2014. The County Clerk is required to report said adopted fees no later than October 15, 2014 to the Comptroller of Public Accounts. Once adopted the 2015 fees will be distributed by the County Clerk to all offices responsible for collecting Sheriffs' and Constables' fees.

Prior drafts have been provided to Sheriff Walker, WCSO Chief Deputy Kevin Benton, all constables and all court members for review. The only fee changes from 2014 to 2015 are listed below. All other fees remain the same.

Change From:

Sheriff's Commission on Recovery of Execution:

Property Going to auction: A 10% fee will be levied for any property sale of \$5,000.00 or less. A 5% fee will be levied if said property sale is greater than \$5,000.00.

To:

Sheriff's and Constable's Commission on Recovery of Execution:

Property Going to auction: A 10% fee will be levied for any property sale of \$5,000.00 or less. A 5% fee will be levied if said property sale is greater than \$5,000.00.

Added (entire section per Sheriff's request):

Pursuant to Local Government Code Section 118.131 and Attorney General Opinion JM-1046 (1989), the expenses for providing the services indicated to unsuccessful service of process are equal to or exceed the expenses of actual service and the fee is thus set at the same cost charged for actual service.

Pursuant to Rule 126 of the Texas Rules of Court, all fees, for any/all civil cases originating outside the County of Wise and/or the State of Texas must be collected in advance except when Paupers Oath is filed. The sheriff or constable will not execute any process until fees are received.
